## REGULATIONS

Art. 1 ENTRANCE FEE to the workshop, including insurance, is 15 euros. This fee is mandatory and never unredeemable. mustn't pay the entrance fee.

Art. 2 Each workshop is set on 6 classes. WORKSHOP FEES are:

1 class 40 €

6 classes 210 €

12 classes 360 €

18 classes 450 €

OPEN CARD 500 €
