

## Fondazione Regionale Arte nella Danza Città di Ancona ART OF DANCE COMPETITION 29/06

#### **REGULATIONS**

The Competition is open to groups, dance high schools, associations, schools, formations and soloist.

In the application form, it will be possible to select a section: **Pre-professional, Amateur**.

- The styles are: <u>ballet, character dance, modern, contemporary and hip-hop</u>. They will be divided in categories: <u>9-11 years old, 12-14 years old, 15-17 years old, 18-25 years old.</u> Special category: <u>6-8 years old.</u>
- Groups are from 3 to 5 people; to choose the category consider the average age of the dancers.
- Formations are form 6 people; to choose the category consider the average age of the dancers.
- Each soloist/duet/group/formation can participate with a maximum of 2 choreographies for each section.
- The participation is subordinated to the payment of a fee for each Deadline for payment of fees is **10**<sup>th</sup> **May 2024**.

### Fees from 9-25 years old:

Soloists: 80 €

Duets: 70 € per person Groups: 40 € per person Formations: 30 € per person

#### Fees for Special Category 6-8 years old:

Soloists: 35 €

Duets: 30 € per person Groups: 25 € per person Formations: 20 € per person

- Each soloist/duet/group/formation must complete the whole **application form** on the website <a href="https://www.artedanzaancona.it/international-dance-summit-2">https://www.artedanzaancona.it/international-dance-summit-2</a> and send it to <a href="mailto:info@artedanzaancona.it">info@artedanzaancona.it</a>. The deadline is **10**<sup>th</sup> **May 2024**.
- Time limit for the choreographies is 4 minutes for duets, groups and formations and 3 minutes for solos. Pas-de-deux from ballet repertoire will have time for original adagio and coda (no variations).
- The jury reserves the right to stop the music if it exceeds the limit by more than 10 seconds.
- Scenery is not allowed, participants can use small props that can be easily removed by the dancers themselves.
- Participants must have their own costumes.
- In Ballet section pointe shoes are allowed from the age of 11.
- All the participants must have a current MEDICAL CERTIFICATE (a photocopy) that attests their healthy constitution.
- Choreographies from ballet, modern or contemporary repertoire can participate as well as original pieces.
- Music must be sent in MP3 format by 31st May 2024.
- Each track must have: name of the soloist/duet/group/formation, category, section, title of the choreography, name of the artistic director, composer and duration.
- The Competition takes place at the Teatro delle Muse di Ancona, which dimensions are 16x14 with a 2,5%slope. Stage will have: linoleum, sound and light service.
- It is forbidden to ask for different lights than the given ones.
- Only one companion per school can access the backstage.
- For each category will be given: 1st, 2nd and 3rd price plus mentions. The Jury may also award cash prizes and scholarships.

- The SPECIAL PRIZE of the Art of Dance Competition will be awarded, thanks to which the winner will be able to perform during the 'Grand Galà di Danza' on 7<sup>th</sup> July 2024 together with international étoiles from all over the world.
- Members of the jury will be national and international qualified figures of the world of dance and art.
- Juror's decisions are final.
- Marks will be from 1 to 10.
- Evaluations will be made of: technique (40%), artistic impression (30%), originality (20%), costumes (10%).
- **A)** All participants must have insurance in case of accident during the event.
- **B)** The Administration considers itself exonerated from any civil and criminal liability relating to the participation in the event, also declining, for the entire course of the event, any liability to persons and/or things.
- **C)** Each participant and/or parent of a minor participant authorizes the Organization to use their image and to process their personal data, in compliance with current legislation and in particular in compliance with Legislative Decree n.196/2003, as well as of the European Reg n.679/2016 (GDPR).
- **D)** For any controversy that may arise in relation to these Regulations, whether in any case connected to the performance of the event in question, the Court of Ancona will be competent.
